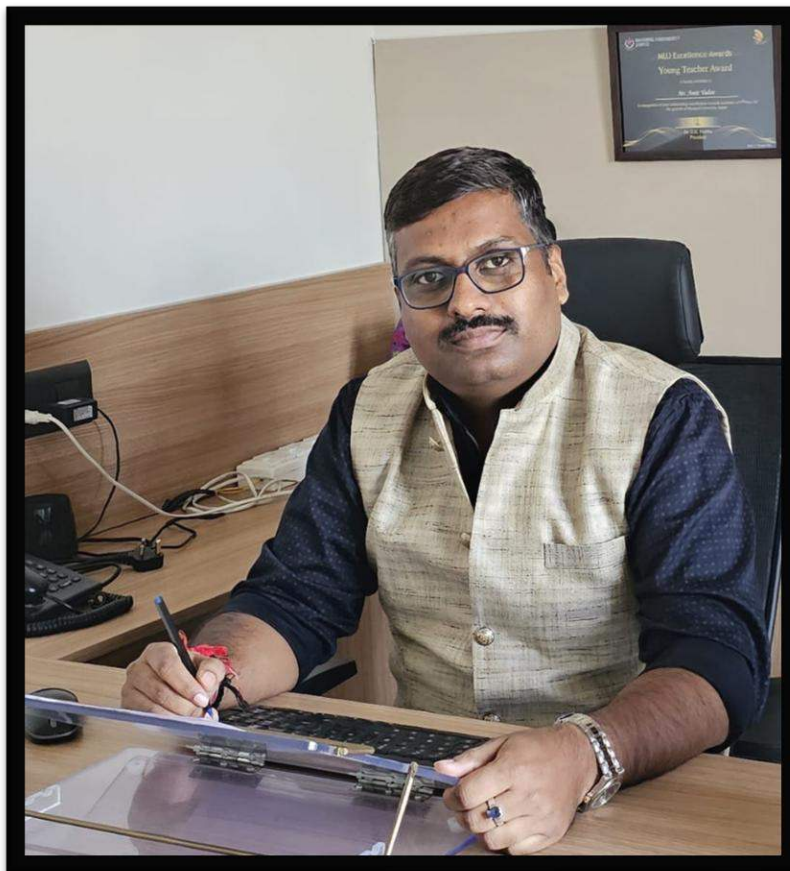

7. AUTHORSHIP:

A maximum of 2 co-author(s) are permitted. Submissions of more than 2 co-authors(s) shall be disqualified.
